History and Purpose of the OWANA Affordable Housing Fund

The Old West Austin Neighborhood Association (OWANA) Affordable Housing Fund has existed since 2011 and seeks to promote and expand access to and the availability of affordable housing within the Old West Austin neighborhood. HOMEBase, an affiliate of Habitat for Humanity, administers the funds for OWANA. In the past, the Fund has been used to support the efforts of the Clarksville Community Development Corporation (CCDC) to acquire, construct, and maintain CCDC's affordable housing units. In 2019, OWANA intends to expand the impact of the Fund to assist low-income individuals and families with their affordable housing needs, while also continuing to invite applications for additional affordable housing in Old West Austin.

Eligibility

Individuals and families making less than 80% of area Median Family Income (MFI) are eligible to apply to the OWANA Affordable Housing Fund. Organizations that serve individuals or families below this income threshold are also eligible to apply. OWANA is unable to provide ongoing financial support, so applicants are encouraged to make requests for one-time financial assistance. Successful applicants will be required to verify their income to HomeBase, the nonprofit organization that manages the OWANA Affordable Housing Fund, before funds can be disbursed. Fund recipients will also need to provide a W-9 to HomeBase for tax purposes.
