

Updates: Mopac & Lamar Beach

Mopac

Beginning Saturday morning, February 20, 2016, the Central Texas Regional Mobility Authority will be temporarily reducing northbound State Loop 1 (MoPac) from three lanes to two lanes between Lady Bird Lake and Enfield Road. The lane reduction is needed to create space for workers to begin excavating an underpass that will allow drivers leaving downtown Austin on Cesar Chavez Street to access the new northbound Express Lane.

In addition to the lane reduction, crews will be realigning the two northbound lanes as they come off the Lady Bird Lake Bridge. The realignment will require drivers to navigate a curve. An advisory speed limit of 50 mph will be posted. Drivers are urged to slow down and use caution when passing through the area.

Construction of the express lane underpass is expected to take at least six months. Once work is complete, northbound MoPac will return to its original three lane configuration.

What is the Zoning Committee & What Does It Do?

The OWANA zoning committee was established to support the goals of the Old West Austin Neighborhood Plan to protect residential properties and the residential core of Old West Austin and Clarksville. The Zoning Committee reviews all projects that require zoning changes or other types of permits. The chair sends out all permit notices received from the City of Austin to OWANA members on the list serv. This how all OWANA neighbors are kept informed on projects happening in their neighborhood. The Zoning Committee either contacts applicants directly who then are asked to attend a zoning committee meeting to share their plans or members of the committee are contacted by owners/developers who ask for a meeting.

The committee meets monthly to review all permitted projects and zoning change requests within the OWANA boundaries. The committee works with individual applicants to provide feedback on projects and inform applicants on the goals of the association. The committee acts as an informational source for the applicant and avoids taking adversarial positions on projects whenever possible.

In 2003 OWANA spearheaded the designation of our neighborhood as a National Historic Register District. As part of this effort, all properties within OWANA were researched and classified as either contributing or non-contributing to the Historic District. Therefore, a primary goal of the Zoning Committee is to protect the historic housing stock of contributing properties to ensure that OWANA maintains its National Register status under federal law.

The Zoning Committee also facilitates interaction among project applicants, nearby property owners, and city staff. The goal of the Zoning Committee is to find workable solutions that respect the historic fabric and streetscape of the neighborhood.

The Zoning Committee meets one a month or more if needed. Also members may attend a variety of city meetings including the Historic Landmark Commission, the Planning Commission, the Board of Adjustment, and the Austin City Council whenever neighborhood projects are up for review or when the City is considering major land use policy initiatives. The re-writing of Austin's land use code, Code Next, for example, would fall into this category.

Zoning Report

February 2016

611 West Lynn - Case #NRD-2015-0112 - Proposed demolition permit. Postponed at the applicant's request at the November 16 HLC meeting. City staff recommends historic zoning. At January 25 HLC meeting, commissioners voted to initiate historic zoning. Postponed until March 28 HLC meeting at applicant's request. Case is ongoing.

812 Theresa - Case #NRD 2015-0135 – Proposed demolition permit. Owner met with the Zoning Committee and heard objections to demoing the house and suggestions for applying for a partial demo. He later e-mailed and said that because of the neighborhood's opposition he was postponing until February 22 Historic Landmark Commission meeting. Owner requested another postponement until HLC meeting on March 28. Case is ongoing.

806 Baylor - Case #NRD 2015-121233 – Restore the original appearance of the house; construct new rear addition. Proposal approved on consent calendar at February 22 HLC meeting. *Case is ongoing*.

716 Patterson - Case # NRD 2016-145208 - Remodel and addition. Approved on consent calendar of Historic Landmark Commission at February 22 meeting. *Case is ongoing*.


