## **AISD Update and Big Thanks to the Castile**

Thanks to the Mathews Elementary fun club director, Mary Sullivan, and to the Castile apartments at 807 West Lynn, the street in front of the school may become a little less congested at pick-up time. Mary asked OWANA to propose to the Castile management an option of using their parking lot in the afternoons, and as a good neighbor, the manager agreed to help. As Kirsty Roberts-Lambert, the manager of the Castile, told us, Mathews is such a great school of course we're happy to help! Thanks, Kirsty and Castile, that spirit of cooperation is one of the many reasons this neighborhood is such a great place to live.

Also in AISD news, OWANA met with Schlosser, the developer AISD selected to repurpose its Caruth administration center building across the street from Sweetish Hill. At this point, the discussions are very conceptual. Schlosser asked if neighbors have strong preferences on the use of the property—commercial, residential, retail, hotel? – and on height limits. We will keep you posted as negotiations continue, and please let OWANA know if you have opinions on the redevelopment of that site.

## February 26, 2018 Zoning Report

#### 710 Augusta Avenue (NRD-2018-0012) -

Requesting building permit to reconstruct a two-story duplex which burned down several years ago. No action by OWANA.

**1406-1410 West 9th Street and 905 Maufrais Street (NRD-2017-0087-91)** - Requesting a demolition permit in order to build a multi-family development with up to 28 units. OWANA opposed demolition. Action postponed by HLC until March 26. OWANA working to reach an agreement with developer to preserve contributing structures, improve compatibility, and increase community benefits.

#### 802 Pressler Street (NRD-2017-2023) -

Requesting a building permit for new construction of a 2 1/2 story house. OWANA opposed both demolition of contributing structure and design of new build. Demolition permit approved by HLC on February 27.

#### 1108 West 11th Street (NRD-2018-0002) -


Certificate of Appropriateness for new construction of two new condos in Castle Hill Local Historic District. Action postponed by HLC until March 26.

#### 703 Highland Avenue (SP-2017-0455C) -

Request for an administrative approval of a site plan. A waiver was requested by the owner to not have to build a retention pond for drainage. OWANA wrote a letter opposing the waiver.




**1007 Shelley Avenue (NRD-2017-0097)** -Requesting a demolition permit to construct a new 2-story house. OWANA initially opposed demolition but voted to withdraw opposition after consultation with the owners and architect. Demolition permit approved by HLC on Feb. 27.

Smoot-Terrace Park Local Historic District (C14H-2018-0013) - Requesting a new Local Historic District including Pressler, Highland, Oakland, 6th, and 9th Streets. On February 27, the HLC added West Austin Park to the proposed district and recommended it for adoption by the Planning Commission and City Council.
