



Shade Structures Arrive at West Austin Park

At long last West Austin Park will be getting some respite from the direct sunlight that hits the park and pool during the long summertime months (though these days with all the cold and rainy gloom, it's hard to imagine direct sunlight being a bad thing). The Austin Parks and Recreation Department (PRD) has begun installing a series of shade structures over the playground and pool, slated for completion in March. discussions about possible funding mechanisms, ultimately deciding on the use of development fee funds generated from local development in our neighborhood. 





Rehabilitate and alter the ca. 1918 home, including restoration of an original corner porch. Approved by HLC on February 25, 2019.

1206 West 10th Street (NRD-2018-0062)

Rehabilitate the ca. 1910 home, expand the footprint of the front and rear, and construct a rear two-story addition with a roof deck. Approved by



HLC on February 25, 2019.

1406-1410 West 9th Street (LHD-2018-0031)

Rehabilitate contributing buildings; construct new buildings. Committee Recommendation: Revise the plans to be more compatible with the neighborhood character. Action postponed upon applicant request until March 2019.



C. Affordable Housing

We have been operating under the assumption that we have \$50,000 to spend. Scott and CCDC have reached a rough agreement about this number. Next steps are to do more outreach to get more applications. We will reach out to the Mathews community.

A. Events

Movie night on the second Sat in March! It will probably Lego Batman, and include a Lego related contest before the movie. Grande is sponsoring movie nights, and has donated around \$4,000.

We are also working on a charity event for Mathews, perhaps in May.

We will continue to have a tiered sponsorship system.

A. Membership

Planning a membership push with a door to door campaign to help neighbors understand what OWANA does. We may also develop a bumper sticker that will come with a membership.

We discussed what we might post on the OWANA site, and how to ensure we don't send too many emails to members.

A. Parks

The shade structure is being installed over the pool later this month. We are now beginning to think about creating an amphitheater in the park. "It's my park day" is coming up in March.

Scott discussed the possibility of renaming West Austin Park, perhaps after the Overton family. We also discussed the possibility of putting up a kiosk where we can place historic information about the park and its structures.

(OWANA generally lets CCDC control Mary Baylor Park.)

Things are moving forward with Palma Plaza Park.

Motion to support gathering more information on Richard Overton III and his connection with the park in order to generate a bio and to make a presentation to the general membership meeting in March. We will ask the general membership meeting whether they want to begin the process of renaming the park. Seconded. Passed.

A. Neighborhood Plan

Mike discussed the possibility of reevaluating the neighborhood plan, which is the suggested practice. Scott mentioned that the city does not really pay attention to the neighborhood plan, and some city politicians want to eliminate them anyway.

Erin mentioned that updating our neighborhood priorities (even if not the plan) might help us in upcoming zoning battles like those surrounding CodeNEXT. It could have value to also highlight the ways that the city has ignored our neighborhood plan for 20 years.

Denise volunteered to start the process of looking at the current plan and developing some new priorities.

As a housekeeping matter, Scott mentioned that we need to update the names of the people the city should contact on neighborhood matters.

- A. Zoning (aka Neighborhood Planning Team)
- 1. Erin noted that the new name was not popular with the "Neighborhood Planning Team." The Team will work on a name that they like and get back to the Steering Committee.
- 2. 1013 Blanco is almost all demolished; only a partial shell is there. He received a partial demo permit, which gave him permission to demo all but the front porch, which he demolished. The Team will propose some guidelines to help with compliance. The HLC seems to have no compliance mechanisms at the moment.
- 3. A pair of properties on 6th and Theresa have permission to demolish. They are looking for a zoning change to allow mixed use. That property uses an alley, and the rest of the people who use that alley don't want it to become commercial. They want the alley to remain for residential use only. The neighbors are also against the zoning change more generally. This may be a future battle.
- 4. Cumby's projects seem to be delayed.
- 5. 1313 12th wants to update the house and change the front porch. The Team voted to support the project, pending the HLC's confirmation that changing the porch won't threaten the status of the house as contributing.
- 6. Sinikka and Erin talked with some neighbors about historic signage. Hyde Park was able to do it, but only because they were part of an LHD. CCDC is also looking into historic signage as well.

A. Affordable Housing

The committee met for the first time yesterday. They have gotten three applications for using some of our funds. Marissa recommends approving two applications now, which request things like emergency rental assistance. The total is \$2250. Moving forward, there is some debate about what portion of money we control compared to what portion CCDC controls. But this debate is irrelevant to the two applications in front of us today.

Marissa opined that, going forward, we might give the Affordable Housing Committee the power to disburse money without Steering Committee approval.

Motion to give Affordable Housing Committee the power to disburse money without Steering Committee approval for the three current applications. Passed.

A. Transportation

A. Parks

We are still waiting for details on the pool shade structure. The Parks committee wants more OWANA support for the proposed amphitheater.

Ted gave an update. Orlo and Ellu revised the business membership plans. Individual memberships will now be year to year, rather than allowing people to purchase multi-year memberships. Budget approved.

Orlo discussed his goals of increasing engagement with local businesses. There are about 160 businesses within the OWANA borders. Orlo wants to encourage neighborhood support for these businesses. Plan is to seek sponsors for our various events, for approximately \$1000 per event.

VII. Other Business and Announcements

Siri and Silva, founders of Reset, came to talk about their business. They turn restaurant spaces into co-working spaces during the day. They are currently working with Nightcap.

Marissa discussed affordable housing.

Mike discussed train squealing, and how the railroad folks are continuing to work on it. The city has committed \$2Million to improved crossing at Pressler and other streets, which gets the city closer to a bike/pedestrian connection through Pressler.
