# OWANA Steering Committee Supports...


### **VOLMA OVERTON SR. SHORES**

At the March General Membership meeting, we heard a presentation about Volma Overton Sr., an Austin civil rights activist who was at the forefront of ending segregation in Austin Schools. Members at the meeting considered ideas for honoring Mr. Overton's legacy including: renaming West Austin Park. renaming Lamar Beach, or naming the West Austin Park Pool or Amphitheater after him. The result was a commitment among several members to find out more about the process involved with renaming city properties and bring the issue back to a vote at the next General Membership meeting in June. Last month, after discussing these options further and learning more about the renaming process, the OWANA Steering Committee recommend to the voted to general membership that Lamar Beach be renamed "Volma Overton Sr. Shores." If the general membership votes to support this name change at the June meeting, then OWANA will write a letter to the City to that effect.



For more on Volma Overton Sr.'s legacy and accomplishments here's a link to Volma Overton's Bio and summary at the Texas State Cemetery website.

Lamar Beach is 65 acres of land stretching from Lamar Boulevard to Mopac between the railroad tracks and Lady Bird Lake with thousands of people passing through this strip of parkland every day either by foot on the Lady Bird Lake trail or by vehicle driving on Caezar Chavez. (see image below)



# Parks Committee Submits Amphitheater Concept to PARD

In April, the OWANA parks committee approved and submitted a concept for creating a proper amphitheater at West Austin Park with tiered seating (see images below). The concept now goes through the City of Austin Parks and Recreation Department (PARD) system for approvals.



# May 2019 ZONING COMMITTEE REPORT

### 1406-1410 West 9<sup>th</sup> Street (LHD-2018-0031) and 905 Maufrais Street (NRD-2019-0004)

Applicant seeks to rehabilitate and renovate three contributing buildings and construct several new buildings. The final plans are available at the Historic Landmark Commission website. The Zoning Committee met with applicants on May 16, 2019 and voted to not oppose applicant's plans, with the exception that the applicant redesign back building to be two buildings instead of one.

### 1115 West 11<sup>th</sup> Street (LHD-2019-0016)

Applicant seeks to construct a 2-unit residential building. The Certificate of Appropriateness committee recommended that applicants move garage entrance to side or rear, at least 15' from the front wall, and use materials more compatible with contributing buildings. The Zoning Committee met with applicants on May 16, 2019 and voted to not oppose applicant's plans.

### 1804-1808 West 6th Street

Applicant seeks to rezone the properties from SF-3 (residential) to LO-MU-NP (commercial). The Planning Commission considered the application on May 14, 2019 and revised its recommendation to NO-MU-NP (mixed-use) after numerous neighbors expressed concern about the negative effects such rezoning would have on the residential neighborhood. A valid petition opposing the rezoning application has been submitted to City Council, which will hear the case on June 6, 2019.

Some people were hesitant to recommend changing the name of West Austin Park given the vocal resistance at the last membership meeting.

Motion to 1. recommend to the general membership meeting that Lamar Beach be renamed "Volma Overton Sr. Shores", and 2. If the general membership meeting support this, OWANA will write a letter to the City to that effect. Passed.

### A. Affordable Housing - Marissa

No update. Still need applications. Marissa will send application to Steering Committee. Derek will post PDF to OWANA website.

### B. Events - Orlando/Ellu

Ellu: Spring Eggstravaganza (egg hunt) is scheduled for Saturday, 4/20. Swedish Hill donating pastries.

May 24 - last day of school celebration at the park w/ live music. City has given the approval to open the Pool during the party!

July 4 - Still looking for a marching band. HONKTX already booked.

Ellu will send out new t-shirt design w/ new logo once Will Heron gets them.

Orlo: Sat. May 4 - Fundraising/Awareness event for Mathews Elementary - Trying to raise funds/awareness for Mathews. We have \$3500 set aside, and trying to raise about \$10K from the neighborhood for Mathews. Have 3-4 non-Mathews parents as "anchor families" who have shown an interest in helping.

- -have secured a home and musician. Looking to get ~40 people to promote, preserving Mathews School. School lost \$40K in funding last year.
- The needs: 1 in 5 kids at Mathews are low-income Orlo will have draft of these details to send out so neighbors can share with past Mathews families and non-Mathews families in neighborhood.

### C. Membership - Sinikka

Lindsey Heron taking over business membership duties. Hope to focus Steering Committee members on doubling down on increasing residential memberships. Maybe door-to-door drive, etc. We have had some new members join recently. Rosemary will work on getting nonprofit stamp.

### D. Parks - Ellu

Brockett put together architectural concept for amphitheater; Ellu will send to full SC. We submitted application to PARD that we want to do this project. Good to have proposal vetted in the community. PARD reviews the apps starting 4/1.

### E. Technology - Derek

Someone requested for minutes to be posted on website. So please send things to Derek to post. Rosemary wants agenda and time/date to be on the website.

### F. Transportation and Public Safety - Mike No updates

### G. Zoning (Neighborhood Planning) - Erin

Proposal that Zoning contribute to lobbyist who is monitoring bill related to historic landmark. Property can't be designated landmark (not districts) in Texas over objection of owner. Concern that other things will be added to the bill. Vote was unanimous at Zoning Committee was unanimous to contribute \$2000. Erin can get the name of the lobbyist. Zoning Committee has about \$5000 in budget. Money will go to Preservation Austin to support lobbyist. Motion passes unanimously.

Cumby offered to have a meeting re: 9th Street Development. Friday meeting 4/5, location TBD.

Member of Zoning Committee drafted letter to give to new owners of properties in LHD's. This prompted discussion of welcoming people to OWANA. Membership welcome packet including info, coupons, OWANA stickers, etc.

Hearing on Thursday on Short-term rental bill. Urban Affairs at 8am. HR 3776

OWANA's position on proposals to rename our parks

1. Old West Austin Park Renaming Proposal

### 2. Lamar Beach Renaming Proposal

Ellen emailed suggestion that we switch parks we are focused on and rename Lamar Beach Park after Volma Overton.

Ellen: it would be a waste to attach his name to a small neighborhood park; better to do it for a larger park that's more used, visible, etc.

It may be that Lamar Beach is a regional/metro park, not just neighborhood park. A Metro Park can't have a 501c "friends of"

Kim: could name a portion of the park (pool, amphitheater, etc.) of West Austin Park.

Rosemary opposed to renaming West Austin Park.

Volma (Grandson of Volma Overtson): neutral on proposals; Overton Shores is one idea. Volma opposed to diluting the name by only naming a portion of the park.

Unofficial Poll of those in attendance: attendees favored renaming A park (not specific which one) in theory.

Ellu: main prerequisite to renaming, and must demonstrate community support for renaming, tell a story, and must have council approval. Must provide description of cultural, geographic, etc. significance. No requirement of direct connection.

Plan before next Steering Committee Meeting: 1. Educate neighborhood re: Volma Overton, 2. do research on renaming process (what happened w/ Roy Guerrero Park), and reach out to city re: what will this entail to rename a park like Lamar Beach vs. West Austin Park, 3. then Steering Committee can make recommendation on various proposals before us to general membership of a plan. Kim will reach out to her contacts at City and Ellu will also talk to folks at the PARD to learn more. Volma Overton story will be included in the next OWL prior to the Gen. Membership Meeting.

A. Endorsement of WAP Community Garden - Letter to PARD

PARD needs OWANA endorsement of community garden. Ted wrote a letter. Unanimous support for Ted writing letter in support of the Community Garden.

This is Orlando Castillo's last meeting as a member of the steering committee since he's moving to Northwest Hills. We don't think he's going away for good, but we appreciate all his dedication and the impact he's had on our community while he's been here.

#### Misc

Mark Bozyk, a member of the Austin Police Department came to introduce himself. He works nights in our neighborhood. He noted that the major issues in our neighborhood seem to be low level mischief like vandalism or rummaging through cars with open doors. He fielded questions. Thanks for coming, Mark!!

### **Mathews Friends for Excellence**

Ted introduced this group, who are trying to raise money for the Mathews community. They are currently looking into restoring the building while simultaneously adding some curriculum about architecture and restoration for the students. Contact Ruth ann Rushing for details (see OWL for her contact info).

#### Yedi Mindfulness

Kellie Dowell, a former Mathews teacher, came to talk about her program for kids on mindfulness. Thanks to a grant from the PTA, she teaches mindfulness lessons on peace to each class. She also runs an after school program. She is looking for a new home for the program, so if you have ideas, let her know. (kellie.dowell@att.net) Thanks Kellie!!

### **Renaming West Austin Park**

Scott Marks and Kim Overton came to talk about renaming West Austin Park. The idea is to bring more history to the Park. The Park appears on maps in about 1935, and was originally named the West 10th st Park. Scott found a number of pictures of the Park and the pool from the late 1930s. From the early 1960s, some pictures illustrated a good deal of racial integration among the kids in the Park. Scott proposed renaming the park after Volma Overton, Kim's grandfather. Kim went to school at Mathews and now lives in the neighborhood with her children attending Mathews.

Kim presented her grandfather's story. He was in the Marines in WWII. Upon his return he was surprised to be confronted with segregation. He went to Huston-Tillotson but could not find a job in his field. But he got a job in the post office and was a postmaster in Bastrop. He was president of the NAACP for 21 years--from 1962-1983. Several people reported that Overton built bridges between east and west Austin. He conducted a peaceful "read in" in 1964 to protest the city councils inaction.. He created groups to test whether businesses were complying with anti-segregation ordinances, and worked against those who did not. He integrated Bastrop State Park, and was involved with early integration of area golf courses. In 1969 he was involved in suing AISD to stop segregation. He is the second black person to be buried in the state cemetery.

Volma never lived in the neighborhood.

The proposed name of the Park is "Overton Park" or "Volma Overton West Austin Park."

#### Other comments:

Some worried that new information would come out that might make us hesitate to name the Park after anyone. Several people wanted to keep the "West Austin Park" portion.

Mike made a motion to "percolate," including considering the possibility of instead naming other portions of the neighborhood after Overton like Lamar Beach. Others wanted more information in the OWL about Overton, and more information about Overton's connection to the neighborhood.

Motion to add this info to the OWL and let things percolate. Passed.

### **Preservation Austin**

Motion to support preservation Austin with a \$200 donation. They often support the neighborhood's preservation efforts.

### **Affordable Housing**

They are working with families who have housing insecurity. They have made two grants, and have been soliciting more applications. They have up to \$50,000 available.

#### **Events**

Movie night:

Orlo discussed Lego Batman movie night this Saturday!

THANKS GRANDE for sponsoring this movie AND the next movie!!

Will Heron, from the neighborhood, will be hosting a lego building event before the movie, with 12,000 bricks!

#### Mathews Fundraiser:

We are still putting this event together, but it probably will be a house party in the neighborhood.

Fourth of July Parade:

This will happen again this year!

Other:

CCDC's Fun fest is coming up!

#### **Membership**

Sinikka took over from George after 6 years. She is working on streamlining the checking in process and the email systems.

#### **Parks**

The shade structures are up in West Austin Park!

### **Transportation**

Mike mentioned that the city has approved money to improve the RR crossing on Pressler st.

We need to take a new look at the neighborhood plan, and Mike is looking for volunteers to begin thinking about this issue.

### **Zoning**

Erin gave a summary of what's been going on at the Historic Landmark commission

- 1. Since the last General Membership meeting, the Historic Landmark Commission has:
- A. Approved a demolition permit for 1808 West 6<sup>th</sup> Street

- B. Approved renovation/building plans for the following properties:
  - 1204 and 1206 West 10<sup>th</sup> Street (rehab and addition) i.
  - 703 Highland Avenue (3-story new build) ii.
  - 1106 West 9<sup>th</sup> Street (new garage/ADU) iii.
  - 707 Blanco Street (addition and ADU) iv.
  - 1108 West 11<sup>th</sup> Street (rehab and addition) ٧.

The house located at 1013 Blanco was unexpectedly demolished—the staff of the Historic Preservation Office is working with the homeowner to make sure the salvageable parts will be refurbished and replaced.

- 1. Relevant plans, permits, and HLC meeting minutes can be found on the HLC website. Please feel free to reach out to anyone on the Zoning Committee if you have questions/comments.
- 2. The next Zoning Committee meeting will be on March 21 at noon.
- 3. The Town Lake Y is converting a softball field to a bigger parking lot.
